SECTION C

GENERAL INSTRUCTIONS TO CONTRACTORS

AND SPECIAL CONDITIONS

1. Online e-tenders are invited for **Providing, supplying & fixing a Three-Layer Industrial Safety Net at RBI, Byculla Office Premises, Mumbai**. The tenders shall be submitted in online manner at MSTCE commerce web site.
2. Tenders shall be submitted online in two parts viz. Part I containing technical and commercial details of the offer and Part II containing prices only.
3. Tenders shall remain open to acceptance by the Bank for a period of three months from the date of opening of the tender Part-I, which period may be extended by mutual agreement and the tenderers shall not cancel or withdraw the tender during this period.

4. The Reserve Bank of India does not bind itself to accept the lowest or any tender and reserves to itself the right to accept or reject any or all the tenders, either in whole or in part without assigning any reasons for doing so.

5. 5% of the total value of work done will be recovered and withheld from their bills by the Bank as Retention Money (RM). The R.M.D. amount shall be released after successful completion of 12 months of Defect Liability Period from the date of completion of the work, provided all the defects pointed out are rectified. Retention Money will be forfeited if he/she/they fails to comply with any of the conditions of contract. No interest will be paid on Security Deposit and Retention Money withheld by the Bank.

6. All compensation or other sums of money payable by the contractor to the Bank under the terms of this Contract may be deducted from his earnest money and security deposit if the amount so permits and the contractor shall unless such deposit has become otherwise payable within ten days after such deductions make good in cash the amount so deducted.

7. The Contractor shall not assign the Contract. He shall not sublet any portion of the contract except with the written consent of the Bank. In case of breach of these conditions, the Bank's Engineer shall serve a notice in writing on the Contractor rescinding the contract whereupon the security deposit shall stand forfeited to the Bank, without prejudice to his other remedies against the Contractor.

8. The Contractor shall carry out all the work strictly in accordance with drawing, details and instructions of the Bank's Engineer if in the opinion of Bank's Engineer and the structural Consultant change have to be made in the design and they desire the Contractor to carry out the same, the contractor shall carry out the same without any extra charge. The Bank's Engineer's/Bank's decision in such cases shall be final and shall not be open to arbitration.

9. A Schedule of probable Quantities in respect of each work and Specifications accompany these Special Conditions. The Schedule of probable Quantities is liable to alterations by omissions, deductions or additions at the discretion of the Bank's Engineer. Each tender should contain not only the rates but also the value of each item of work entered in a separate column and all the amounts quoted against various items should be totaled in order to show the aggregate value of the entire tender.

10. Tenderer must obtain for himself on his own responsibility and at his own expense all the information which may be necessary for the purpose of making a tender and for entering into a contract and must examine the drawings, inspect the site of the work, acquaint himself with all local conditions, means of access of the work, nature of the work and all matters pertaining thereof.

11. The rates quoted in the tender shall include all charges for clearing of site before commencement as well as during and after completion, water, electric consumption, meters, double scaffolding, fencing, hoarding, plant and equipment, storage sheds, watching and lighting by night as well as day including Sundays and Holidays, temporary plumbing and electric supply, protection of the public and safety of adjacent roads, streets, cellars, vaults, ovens, pavements, walls, houses, buildings and all other erections, matters or things and the Contractor shall take down and remove any or all such centering, scaffolding, staging etc., as occasion shall require or when ordered to do so, and fully reinstate and make good all matters and things disturbed during the execution of work and to the satisfaction of Bank's Engineer s. The rates quoted shall be deemed to be for the finished work to be measured at site. The rates shall also be firm and shall not be subject to exchange variations, labour conditions, fluctuations in railway freights or any conditions whatsoever. Tenderers must include in their rates GST. No separate claim in respect of GST shall be entertained by the Bank except if changed by the Central Govt., State Govt. or local authorities during the contract period.

12. (a) The Contractor should note that unless otherwise stated the tender is strictly on item rate basis and his attention is drawn to the fact that rates for each and every item should be correct, workable and self-supporting. The quantities in the Schedule of Quantities approximately indicate the total extent of work but may vary to any extent and may even be omitted thus altering the aggregate value of the Contract. No claim shall be entertained on this account. However, during actual execution of work if the quantities of any of the items of work exceeds by more than 25% of the tender quantities, the quantities of such items executed, by the authority of the Bank's Engineer of the project in excess of 25% of the tender quantity shall be considered as an extra item of work for which the contractor shall submit fresh rates supported by rate analysis worked on the actual cost basis plus 15% towards establishment charges, contractor's overhead and profit. The rate for all such items of work, being current ones, will not be eligible for price adjustment due to increase or decrease in prices of materials and labour rates as per escalation formula, if any, given in the tender.

b) In case of difference in the basic rate of the material, the difference in actual purchase price including GST and excluding cartage, loading, unloading and the basic price including GST (as given in tender) with 15% contractor's profit & overheads shall be adjusted. Copy of the invoices of materials so purchased shall be submitted to the Bank duly verified by the Bank's engineer with the original.

13. Time allowed for carrying out the work is 45 days from the 14th day of issue of work order. If the contractor fails to complete the work within the specified period, they/he shall be liable to pay LD at the rate of 0.25 % per week i.e **Rs. 354/- per day** of estimated cost put to tender subject to a maximum of 10% of the contract amount for the entire work. **The tenderer shall before be commencing work prepare a detailed work programme, which shall be approved by the Bank's Engineer.**

14. The successful tenderers should co-operate with the other contractors appointed by the Bank so that the work shall proceed smoothly with the least possible delay and to the satisfaction of the Bank's Engineer.

15. The contractor shall bear in mind that all the work shall be carried out strictly in accordance with the specifications made by Bank's Engineer and also in compliance of the requirements of the local public authorities and to the requirements of the Bank and no deviation on any account will be permitted.

16. The successful tender should make his own arrangement to obtain all materials required for the work.

17. The tenderers shall submit along with his tender a list mentioning the names of manufactures of specialized items (from the approved materials as per Annex), like plain & perforated board, paint, false ceiling sections, wooden slats etc. all materials including Aluminum sections, M.S structural members, wall/floor tiles/plumbing fixtures and fittings etc. which he proposes to use in the work if his tender is accepted. However, final approval of the materials to be used in the work shall be given by the Bank.

18. The contractor is allowed to use the water available in the flat where the work is to be done and no recovery shall be made from the bills towards the water consumption charges for the work. However, contractor shall compensate this free service in the quoted rates.

19. The Contractor shall strictly comply with the provision of safety code annexed hereto.

20. The Security deposit (RMD) of the successful tenderer will be forfeited if he/they fails to comply with any of the conditions of contract.

SECTION 'D'

SPECIAL CONDITIONS

1. The workmen will not be allowed to stay within the premises unless or otherwise provided specifically. If permitted to allow staying within the colony, then labours shall strictly maintain the discipline, proper behavior, shall not roam within the colony unnecessarily, etc.
2. The water required for the work or workmen can be availed from the available source at site free of cost. The Contractor has to tap the same from the point shown to them at their own cost.
3. The electric power required for the work can also be similarly drawn from the supply available at site free of cost. The Contractor has to tap the same from the point shown to them at their own cost.
4. Permission, if any, required from the local bodies shall be obtained by the Contractor at his cost.
5. The work is to be executed in occupied office building and therefore work will be allowed only after office hours, Saturday, Sundays and holidays. Contractor shall consider this while quoting their rates. Contractor shall deploy sufficient manpower to complete the work within contract period.
6. Proper day to day cleaning shall be done of the area after completion of day's work failing which same will be done through other agency at risk and cost of the contractor.
7. The intending Bidder can obtain any clarifications regarding the quotation drawings, specifications etc. if any from the office of the Chief General Manager, Reserve Bank of India, Estate Cell, Byculla, Mumbai 400 008 on any Bank's working day.
8. Fabrication shall be done at site only at location directed by Bank's engineer.
9. The entire materials for the work shall be brought to the working area through the staircase.
10. Wherever the basic rate for the material is specified, the contractor should provide to the Bank for verifications all paid bills/ bank's statement of transaction towards purchased materials for ascertaining the actual rate of purchase so as to settle the difference in cost of material. The rate shall be got approved from the Bank before purchasing. The adjustment in price of materials shall be made on Lump Sum quantities as indicated in the BOQ or on measured quantities wherever item quantities are mentioned. No overhead, wastages or profit shall be considered on the cost difference. The basic price for the materials shall be taken as the cost of material at dealer's go-down and transportation, loading and unloading charges etc. shall be included in the

lump sum rate quoted for each item. Contractor shall submit tax invoice bills of purchased materials along with the RA bills, without which the bill will not be accepted.

11. Debris formed in the work shall be brought down, stacked at location specified by Bank's engineer and shall be removed as per Bank's advised, failing which same will be got done at risk and cost of the contractor.
12. The Bidder shall use only approved branded materials.
13. No lapses from the Contractors side, which may cause damage to the property and injury to the occupants/neighbours in the opinion of the Bank's Engineer, shall be permitted.
14. The work has to be carried out with least inconvenience to the Office Bearers.
15. The Contractors shall dispose of the debris generated in the work in approved location by the MCGM and permission if required any shall be obtained by the contractor.
16. The contractor should have valid Labour license from Labour Commissioner wherever the number of labourers engaged is 20 or more.
17. It shall be the responsibility of the contractor to prepare and submit Good For Construction auto CADD drawing, within 10 days from date of issue of work order, for Bank's approval and accordingly the work cabin layouts shall be executed.
18. Final quoted quotation amount, of respective contractor, will be derived adding of GST components and same will be the criteria for deciding of the lowest bidder. If any contractor has written the total amount in the quotation and have not entered the GST components, then GST component will be derived from the total quoted amount.
19. The contractor shall have the addresses and photographs of their workmen being engaged by them for the said work. The entry of workmen will be allowed inside the building only on producing the photo pass issued by the Bank's Caretaker.
20. Before quoting the rates, the contractor should inspect the site and understand the nature and scope of the work for themselves.
21. Any damage cause to any of Bank's properties shall be made good by the contractor at their own cost.
22. The contractor shall carry out the work strictly in accordance with specification details and instructions of the Bank's Engineer.

23. The Contractor shall make their own arrangements for storing of their materials at site.
24. The Contractor shall keep the Bank indemnified against all claims, if any.
25. The work has to be done in the common area, where in the movement of the occupant will be there. Hence, contractor has to consider the same.
26. The Contractor shall ensure payment of minimum wages to the workmen employed by him and obtain their signature or thumb impression on wage slip. A copy of such wage slip shall be submitted to the Bank.
27. The Contractor shall ensure payment of minimum wages to the workmen employed by him shall maintain a Register of wages and shall issue a wage slip to every workman employed by him and obtain their signature or thumb impression on the wage slip. A copy of such wage slip shall be submitted to the Bank.
28. Labours engaged in the work shall strictly comply to the safety measures necessary to prevent spread of COVID 19 failing which Bank will take necessary action including dismissal of particular labour violating the COVID safety guidelines.

29. Insurance in respect to damages to persons and property

- i. The Contractor shall be responsible for all injury or damage to persons, animals or things and for all damage to property which may arise from any factor omission on the part of the Contractor or any Sub-Contractor or any nominated Sub-Contractor or any of their employees. The liability under this clause shall cover also any damages to structures, whether immediately adjacent to the works or otherwise; any damage to roads, streets, footpaths, bridges as well as damage caused to the buildings and other structures and works forming the subject matter of this contract. The contractor shall also be responsible for any damage caused to the building and other structures and works forming the subject, matter of this contract due to rain, wind, frost or other inclemency of weather. The contractor shall, indemnify and keep indemnified the Bank and hold him harmless in respect of all and any loss and expenses arising from any such injury or damage to persons or property as aforesaid and also against any claim made in respect of injury or damage, whether under any statute or otherwise and also in respect of any award or compensation or damage consequent upon such claims.
- ii. The Contractor shall, at his own expense, effect and maintain till issue of the virtual completion certificate under this contract, with an insurance company approved by the Bank, **an All Risk Policy for Insurance for the full amount of the contract including earthquake risk in the joint names of the Bank and the contractor (the name of the former being placed first in the policy) against all risk policy**

- for contractors** and deposit such policy or policies with the Bank before commencing the works.
- iii. The contractor shall reinstate all damage of every sort mentioned in this Clause so as to do delivery of the whole of the works complete and perfect in every respect and so as to make good or otherwise satisfy all claims for damage to property or third parties.
 - iv. The Contractor shall also indemnify and keep indemnified the Bank against all claims which may be made against the Bank by any person in respect of anything which any arise in respect of the works or in consequence thereof and shall at his own expense, effect and maintain until the virtual completion of the contract, with an Insurance Company approved by the Bank a policy of Insurance in the joint names of the Bank and the Contractor (name of the former being placed first in the policy) against such risk and deposit such policy or policies before commencement of the works. **The minimum limit of the coverage under the policy shall be Rs.2 lakh per person for any one accident or occurrence and Rs.5 lakh in respect of damage to property for any one accident or occurrence subject to an overall ceiling of Rs.10 lakh.** The contractor shall also indemnify the Bank against all claim which may be made upon the Bank, whether under the Workmen's Compensation Act or any other statute in force, during the currency of this contract or at Common Law in respect of any employee of the contractor or of Sub-Contractor and shall at his own expense effect and maintain until the virtual completion of the contract or with an Insurance Company, approved by the Bank, a policy of insurance against such risks and deposit such policy or policies with the Bank from time to time during the currency of this contract.
 - v. In default of the contractor insuring as providing above, the Bank may so insure and may deduct the premiums paid from any moneys due or which may become due to the contractor.
 - vi. The contractor shall be responsible for any liability which may not be covered by the Insurance Policies referred to above and also for all other damages to any person, animal or defective carrying out of this contract, whatever, may be the reasons due to which the damage shall have been caused.
 - vii. The contractor shall also indemnify and keep Indemnified the Bank against all and any costs, charges or expenses arising out of any claim or proceedings relating to the works and also in respect of any of damage or compensation arising there from.
 - viii. Without prejudice to the other rights of the Bank against contractor in respect of such default, the Bank shall be entitled to deduct from any sums payable to the contractor the amount of any damages, compensation costs, charges and other expenses paid by the Bank and which are payable the contractor under this clause.
 - ix. The Contractor shall upon settlement by the insurer pursuant to a policy taken under this clause, proceed with due diligence to rebuild or repair the works destroyed or damaged. In this event all the monies received from the Insurer in respect of such damage shall be paid to the Contractor and the contractor shall not be entitled to

any further payment in respect of the expenditure incurred for rebuilding or repairing of the materials or goods destroyed or damaged.

- x. The contractor, in case of re-building or reinstatement after damage shall be entitled to such extension of time for completion as the Bank's Engineer may deem fit, but shall, however, not be entitled to reimbursement by the Bank of any shortfall or deficiency in the amount finally paid by the insurer in settlement of any claim arising as set out herein.
- xi. Without prejudice to his liability under this clause, the contractor shall also cause all nominated sub-contractors to effect, for their respective portions of the works, similar policies of insurance in accordance with the provisions of this clause and shall produce or cause to produce to the Bank such policies. The contractor shall not permit a nominated sub-contractor to commence work at the site unless the said insurance policies are submitted. In the event of failure of the sub-contractor to take out such a policy of insurance before commencing the works at the site, the contractor shall be responsible for any claim or damage attributable to the said sub-contractor. If the contractor fails to extend the insurance policies at any point of time, Bank will take the insurance & triple of the insurance premium will be recovered from the contractor.

Safety Code

1.	An injured person shall be taken to a public hospital without loss of time, in cases where the injury necessitates hospitalization.
2.	First aid kit shall be maintained at site with all necessary medicines.
3.	No portable single ladder shall be over 8 meters in length. The width between the side rails shall not be less than 30 cm (clear) and the distance between two adjacent rungs shall not be more than 30 cm. When a ladder is used an extra mazdoor shall be engaged for holding ladder.
4.	The excavated material shall not be placed within 1.5 meters of the edge of trench of half of the depth of trench whichever is more. All trenches and excavations shall be provided with necessary fencing and lighting.
5.	Safety equipments like gloves, face shield, safety goggles, safety shoes and helmets shall be compulsorily provided for the welding team including wearing of apron printed with the company's name. All other labors shall be provided with safety helmets, safety shoes and apron. Cost will be recovered if failed to provide the above safety equipments. In addition to these, if required, other necessary safety equipments shall also be provided without any extra cost.
6.	No floor, roof or other part of the structure shall be so overloaded with debris or materials as to render it unsafe.
7.	Workers employed on mixing and handling material such as cement mortar or concrete shall be provided with protective footwear and rubber hand gloves.
8.	Those engaged in welding works shall be provided with welder's protective eye-shields and gloves.
9.	(i) No paint containing lead or lead products shall be used except in the form of paste of readymade paint.
	(ii) Suitable facemasks should be supplied for use by the workers when the paint is applied in the form of spray or surface having lead paint dry rubbed and scrapped.
10.	Overalls shall be supplied by the Contractor to the painters and adequate facilities shall be provided to enable the working painters to wash during the periods of cessation of work.
11.	Hoisting machines and tackle used in the works, including their attachments, anchorage and supports shall be in perfect condition.
12.	The ropes used in hoisting or lowering material or as a means of suspension shall be of durable quality and adequate strength and free from defects.
